Call for Artists With Disabilities Who Live in San Mateo County

Theme and Eligibility: The **Disabilities Art Showcase** of San Mateo County is open to artists with disabilities who live in San Mateo County. Artists are encouraged to submit artwork that exemplifies their personal views of the world.

Entry: Only ONE wall-hung artwork per artist will be accepted if they meet the following criteria for eligibility:

- Works have not been shown previously in the Community or Caldwell Galleries and must not be older than 5 years old.
- Artist delivers his/her works, along with application to **400 County Center, Redwood City** on **Monday, October 1, between 9:00 and 11:00 a.m.** (*No late works will be accepted.*)
- Minimum size of finished work is 18" on any one side with a maximum of 36" on any one side. Maximum depth is 3" and maximum weight is 30 lbs. per piece.
- Artist signs a release of liability (see next page).
- Works are dry, framed (wrap canvases are fine), and **wired for hanging** (NO Saw Tooth hangers).
- Works are labeled on the back with the artist's name, address, phone number, and price (use "NFS" for "not for sale").
- Work contains no images of nudity, religion, politics or violence due to the nature of public business conducted at 400 County Center.

Exhibit will show from Tuesday October 2 through Tuesday, October 31, 2018. The Caldwell and Community Galleries are open from 8 a.m. to 5 p.m., Monday through Friday.

Pickup of Artwork: Artist (or a designated person in place of artist) must pick up his or her art on **Wednesday, October 31, 2018** from the Caldwell Gallery, 400 County Center, Redwood City, 9:00 a.m. –11:00 a.m. There are no facilities to store artwork. Bring Exhibitor's Record Receipt.

Placement of Work: Art will be installed at the Caldwell Gallery (main lobby).
